In order to promote a healthy and safe environment at North Park University, we require each member of our incoming undergraduate class to complete two online courses: AlcoholEdu for College and Haven—Understanding Sexual Assault. These programs are designed to empower you to make informed decisions about alcohol and relationships as well as prepare you to respond appropriately to the varying situations and influences you might encounter on a college campus.

# What are AlcoholEdu and Sexual Assault Prevention?

Developed by EverFi, a national organization seeking to support high school and college students with critical life skills such as alcohol abuse prevention, sexual assault awareness, and financial literacy, both programs utilize a non-biased, datadriven curriculum. Both courses are confidential, personalized, and consist of two parts each (see above), requiring roughly two to three hours to complete. Hundreds of thousands of college students across the country complete these courses each year. They include the following resources to help you become better informed about important issues that affect your college years and beyond:

- Alcohol-related content featuring videos and hands-on activities
- Helpful tools, like a Blood Alcohol Concentration (BAC) calculator and map of U.S. laws
- Tools and scenarios to define and promote healthy relationships and help spot the warning signs of abuse
- Skill-building exercises and strategies
- Concise, accessible, engaging (and private) educational platform

# How do AlcoholEdu and Sexual Assault Prevention help students?

Surveys of more than 200,000 students who completed the courses report the following results:

- 75% said AlcoholEdu provided them with helpful information and 66% said it helped them learn new facts about alcohol.
- 81% reported AlcoholEdu prepared them to identify the signs of alcohol poisoning and 83% reported AlcoholEdu prepared them to help someone who may have alcohol poisoning.
- 64% said the information presented about BAC would help guide them in creating a plan for making safe and healthy decisions.
- 72% of students who took Haven said they were confident in their ability to support a friend who has been sexually assaulted.
- 79% said they have a good understanding of the definition of sexual assault.
- 81% said they would respect someone who intervened to prevent sexual assault.

#### What am I required to do?

Every incoming North Park University student is expected to complete the AlcoholEdu for College and Haven – Understanding Sexual Assault courses. To fulfill this requirement, you must achieve the following:

- Complete Part 1 for both courses (approx. 2–3 hours total) by January 3, 2020
- Complete both final exams. You must score 75% or higher on Alcohol Edu.
- Complete Part 2 (approx. 15 min each) by February 14, 2020

#### Next Steps

Here are the steps new students need to take to complete the AlcoholEdu for College and Haven – Understanding Sexual Assault courses:

Log in at EverFi

1. Go to: www.everfi.com/register

2. Enter registration code f1fe40e7

If you already have an EverFi higher education account, go to the above URL and click "Log In." Once signed in, go to your settings to add the College Registration Code.

Enter Your North Park Student ID Number

When prompted, please enter your student ID number, which you can find on your student account bill, on your class schedule, or in WebAdvisor.

Other Important Information

- You will need Internet access and audio capabilities.
- For best results, please use a version of any major browser released in the past two years.
- You may take the course in multiple sittings. Sections end with a "Next" button; DO NOT log out until you click the "Next" button or you will be forced to repeat the section.

- The course may include surveys to help personalize your experience and measure students' attitudes and behaviors. All survey responses are confidential. North Park will only receive information about the student body as a whole and will never see individual students' answers.
- Should you experience technical difficulties, click the "Help" button to access the 24/7 help center.

### Title IX and North Park's Sexual Assault Policy and Procedures

Title IX of the Education Amendments Act of 1972 is a federal law prohibiting sex discrimination by entities that receive federal funds, including educational institutions. The law is enforced by the U.S. Department of Education, Office of Civil Rights. Based on this federal law, Title IX, North Park has adopted a strict Policy Against Discrimination, Harassment, Sexual Misconduct, Relationship Violence, and Retaliation.

As a Christian institution of higher education, North Park is committed to providing a campus environment characterized by mutual respect among students, faculty, and staff. In this regard, it is the policy of North Park University that any form of sexual offense will not be tolerated. This policy applies to all members of the campus community: students, faculty, staff, and visitors. It applies to incidents that occur on campus property as well as any off-campus functions sponsored or supervised by the institution. North Park is committed to educating the campus community about the prevention of sexual assault, providing support services to victims of sexual assault, investigating thoroughly alleged incidents of sexual assault, and disciplining student and employee perpetrators of any such acts of violence.
