

Waiver & Release Agreement for Student Storage

THIS AGREEMENT made on \_\_\_\_\_\_between North Park University, an Illinois not for profit corporation (hereinafter "North Park University") and \_\_\_\_\_\_ (hereinafter "student"), a residential student at North Park University.

I, \_\_\_\_\_\_, am a student at North Park University and am over eighteen years of age, or I have a parent or guardian signing on my behalf. By completing this I am acknowledging that I:

 Am unable to return to the North Park University campus to move my belongings out at the end of Spring Semester 2020, and am asking North Park University to pack and store my personal property until I return to campus for Fall Semester 2020.

I agree to permit the storage of certain of my personal possessions which will be loaded and unloaded on the North Park University campus by North Park University staff. I understand and acknowledge that it is entirely my responsibility to obtain insurance for my personal possessions while they are in storage and in transit. I understand and hereby acknowledge that North Park University is not and will not be responsible or liable for any damage, theft, casualty, loss, or destruction involving my personal property and that North Park University does not carry insurance for any damage, theft, casualty, loss or destruction involving my property which is in storage or in transit. I understand and hereby acknowledge that if my property is damaged, lost, stolen or destroyed for any reason or by any cause, including but not limited to acts of God, nature, weather, fire, theft, temperature or otherwise, North Park University is not responsible therefore; and, in such an event, my only recourse will be any insurance coverage that I have or my parents or guardians have on my behalf.

I agree as follows:

- To release, acquit and forever discharge North Park University and its employees, agents, servants, officers, trustees and representatives from any and all liability, claims, demands, actions, causes of action, judgments, costs, and expenses (including reasonable attorneys fees) which I now have or may have in the future, of whatever kind or nature and howsoever originating, which arise from or by reason of any loss, damage, injury or destruction of property during or in connection with the loading, unloading, storage or transport of my personal possessions.
- 2. I understand and hereby acknowledge that North Park University makes no warranty or representation of any kind concerning the quality or condition of the storage location on which my personal possessions will or may be stored and I hereby knowingly and voluntarily assume

the risk of any loss, damage or destruction resulting from any defect on or in the semi-trailer on which my personal possessions are stored.

3. In signing this Waiver and Release, I hereby acknowledge and represent that I have read the foregoing Waiver and Release, that I understand its content and terms, and that I understand that such terms are contractual and sign it voluntarily.
