## P425E200431 – HEERF Student Relief Funding North Park University 2022 Quarter 1 (January 1 through March 31, 2022) Report

On March 27, 2020, the President of the United States signed the CARES Act (H.R. 748), providing emergency relief funds to organizations and individuals affected by the coronavirus pandemic. The Higher Education Emergency Relief Fund (HEERF), found in Section 18004 of the CARES Act, provides funding to institutions of higher education "to prevent, prepare for, and respond to coronavirus."

On December 27, 2020 the President of the United States signed into law the Coronavirus Response and Relief Supplements Act (CRRSAA), providing additional funding to HEERF allowing for supplemental awards to be made to institutions of higher education under their existing CARES Act grant agreements.

On March 11,2021, the President of the United States signed into law the American Rescue Plan (ARP), also providing additional funding to HEERF and allowing for supplemental awards to be made to institutions of higher education.

This report provides details on the funds North Park University distributed to students during the time period of 01/01/2022 to 03 /31/2022 under Award No. P425E200431 and the supplemental funding received through CRRSAA and ARP.

North Park University signed and returned to the Department of Education the Certification and Agreement on April 11, 2020.

## 2) AWARD RECEIVED

North Park University has received the following funds under Grant Agreement P425E200431 - HEERF Student Relief funding to help students who have exhibited the highest financial need to help with emergency costs that have presented as a result of the coronavirus, such as tuition, food, housing, healthcare (including mental health care), or childcare.

CARES Act: \$1,166,436 was received on 4/22/2020 and fully distributed to students by 6/30/2020. CRRSAA: \$1,166,436 was received on 1/19/2021 and fully distributed to students by 3/31/2021

ARP: \$3,357,886 was received on 5/21/2021.
